

These schools serve over 5,000 students. All schools in the program qualify as Title 1 schools.

Additionally the Foundation provided \$25,000 to the Sagamartha Next Foundation to help build the Denali Schmidt Gallery in the Khumbu region of Nepal. The Gallery will provide an artist in residence program and art supplies for the over 400 students that it serves.
